About Blagrave

Blagrave is an independent charity dedicated to serving young people who are challenging and experiencing injustice in their individual lives and within society. We hold investments of c. £44 million, which along with other income sources, funds all the work we do including grant-making. We fund young people directly on a national basis through our Challenge and Change and Pathways funds. Through our place based funding, we provide small grants (usually between £20,000 - £30,000) to grassroots organisations serving urgent needs of young people facing injustice, in Berkshire, Hampshire, Sussex and Wiltshire.

We are committed to centring the voices of those we seek to serve and aim to do this in a variety of ways. This means that our board and staff team have relevant lived and learnt experiences to help us fulfil our mission. We are committed to listening to the communities we seek to serve both directly and broadly to have as accurate of an understanding as possible about the issues that those we're here to serve are facing.

Regional funding

The aim of our regional fund is to enable youth organisations to meet the needs of young people who experience social injustice in the region.

Each year, we allocate at least £300,000 in new funding to youth charities in Berkshire, Hampshire, Sussex and Wiltshire. We are creating the role of regional advisers as part of our strategic goal to share power with the communities we seek to serve. We are creating a team of regional advisers with a range of experiences of both accessing and working in youth services in the region to advise us on grant making in the coming year.

About the role



You will be working as part of a team of advisers to assess ongoing funding applications throughout the year, and make recommendations on funding to Blagrave's CEO and Trustees.

Following a period of induction, your work will involve a monthly meeting online where you will be:

- Assessing initial requests for funding from organisations to advise on which should go forward
- Reading Blagrave's assessments, debating the merits of different applications and ultimately recommending funding decisions to our CEO or Trustees (who retain sign off and accountability)
- Providing feedback on effectiveness and impact of our funding following visits to charity partners.

Consultation and feedback

- Provide a sounding board for Blagrave's wider strategy in the region
- Refining criteria for Blagrave funding in the region

The Advisory Panel will be supported by an external facilitator and Blagrave team members to ensure that all voices are heard equally and each member can play their part.

Why we are doing this

We believe no one knows better about where funding should go in the region than the local youth sector. We think the combination of our grant making knowledge with local expertise is essential to make the best possible decisions on how our resources can best reach the young people we seek to serve.

The most powerful conversations contain; lived, learned and practiced experience and so we want to build an intergenerational panel, made up of those who have a stake in the local youth sector. That's why we are looking to form a group of 8-10 people who have worked in the youth sector as a volunteer, staff member or Trustee in the last 12 months or have accessed and benefited from these services as a young person.

Who we want to work with

We are looking to recruit 6-8 advisers based in or from **Berkshire**, **Hampshire**, **Sussex or Wiltshire**, with experiences of attending and/or working in youth services in these areas. We define youth services as work with young adults 16-25.

You could be:

- Someone who has used youth charity services
- A youth worker working with young people
- An apprentice youth worker
- Someone working within a youth work organisation
- A volunteer in a youth charity
- A young person who has taken part in leadership programme within a youth charity
- A Chief Executive Officer at youth charity
- A Trustee at a youth charity

Or all of the above! You need to have had recent experience (in the last 12 months) of taking a role in or with a youth organisation. The above list is not exhaustive. We are looking for a broad range of experiences, backgrounds, and opinions to create diversity of thought and ideas among the group. **You must be 18 or over to apply** but there is no upper age limit.



We want to hear from you if you are:

- Fully in support of Blagrave's mission and values
- Dynamic and passionate about the support young people need and have a right to access
- Able to communicate your own views and actively listen to those of others, where necessary discussing to come to a consensus
- Able to ask challenging questions, with an open mind
- Empathetic and able to understand different people's backgrounds, personal values, and objectives, even where you do not share them
- Reliable and committed to attending and contributing to regular meetings

We are open to candidates from all backgrounds, but we will prioritize people who will help us to continue to diversify the voices heard in our work. We are committed to creating an equitable environment where all can thrive.

Please note this role is not PAYE and will require successful applicants to either already be registered or to register as self-employed. (Training from an accountant and support will be provided, including specialist benefits advice if required.)

How do you apply?
